Welcome to our first newsletter of 2025!

We are excited to share updates on how the GHLIG has been advancing global health law scholarship and contributing to critical discussions. Below, you'll find highlights from our recent activities and upcoming opportunities to engage further.

I. Call for Submissions Global Health Law Student Essay Competition

In 2024, the GHLIG launched the Global Health Law Student Essay Competition in collaboration with the Journal of Global Health Law. The Essay Competition aims to foster insightful and impactful student-led discussions on crucial health law topics that have international significance.

Each year, the GHLIG will award a Prize to the author of an unpublished paper that a Selection Committee considers to be outstanding in the field of global health law. The selected paper will also have the chance to be featured as a publication in a forthcoming issue of the Journal of Global Health Law. The 2025-2026 Global Health Law Essay Competition is **now open!**

Eligibility

The competition is open to undergraduate and graduate students worldwide who have written papers during the 2024-2025 academic year. Jointly authored papers are not eligible, and ASIL membership is not required.

Topics

The paper must address a significant issue within the sphere of global health law. The competition adopts the framing of global health law offered in the inaugural issue editorial of the Journal of Global Health Law, which recognizes that global health law encompasses:

"...legally binding and non-binding instruments adopted under the framework of the WHO and other relevant international institutions/organizations – first and foremost the Food and Agriculture Organization and the World Organization for Animal Health – and a range of hard and soft law standards recognized in other branches of international law."¹

Regional and sub-regional frameworks within which health-related standards have been adopted, as well as non-state governance, such as through professional bodies, philanthropic and private sector actors, also have important bearing on global public health.

We encourage diverse methodological approaches, including qualitative and quantitative methods.

Criteria

In assessing the papers, the Selection Committee will take into account the following criteria: 1) originality; 2) depth of research; 3) sophistication of the analysis; and 4) potential to have an impact in the field.

Prize

Winners will receive a certificate, complimentary ASIL membership, and a mentor to support publication of their piece in the Journal of Global Health Law.

Submission Guidelines

Papers must be original, unpublished work. They should be between 5000 and 8000 words (including footnotes), in English, double-spaced, and follow a recognized academic citation style. II. 2024 GHLIG Student Essay Competition Winner Announced!

We are delighted to announce Pramita Parwani as the winner of the 2024 GHLIG Student Essay Competition for her paper, 'Beyond Human Rights: Reframing Vaccine Access Through a Framework of States' Capabilities.'

Pramita's paper argues that global vaccine inequity stems not only from human rights shortcomings but also from systemic economic and political challenges. By proposing a 'states' capabilities' framework, she highlights structural barriers to fulfilling human rights obligations in global health

Pramita is a Ph.D. candidate at the Law Centre for Health and Life and the Amsterdam Centre for European Law and Governance (ACELG) at the University of Amsterdam Law School.

III. Past GHLIG Member Events

GHLIG's Matthew Carvalho at the 16th Conference of the Parties to the Convention on Biological Diversity

On 24 October, GHLIG member Matthew Carvalho coordinated a side event hosted by the Sunway Centre for Planetary Health (SCPH) at the 16th Conference of the Parties to the Convention on Biological Diversity (COP16). convened in Cali, Colombia. The event, entitled Planetary Health and International Law: DSI Coherence in a Time of ABS Fragmentation, aimed to highlight how a COP16 decision on digital sequence information (DSI) could more largely influence approaches to access and benefit-sharing (ABS) across international law. Panelists discussed the recently adopted Biodiversity Beyond National Jurisdiction Agreement (BBNJ), the ongoing Intergovernmental Negotiating Body (INB) for a new pandemic preparedness instrument, and the International Treaty on Plant Genetic Resources for Food and Agriculture (ITPGRFA), while referencing other critical fora. The session asserted the need for greater communication across DSI negotiations and agreements, stating that an interconnected understanding of discussions at hand across other conventions is essential to support the achievement of planetary health-informed global governance.

The side event stressed the importance of the INB process, especially the proposed Pathogen Access and Benefit Sharing (PABS) system, emphasizing that decisions from COP16 could influence some of the more contentious discussions on ABS occurring at the World Health Organization. As negotiations continue into 2025, and COP16 reconvenes in Rome, Italy this February, the SCPH will be tracking all relevant ABS and DSI negotiations, hoping to support coherent and cohesive implementation of the adopted DSI decision and the newly established Cali Fund as INB continues.

Professor Gian Luca Burci, joins panel on International Law Responses to Planetary Threats at National University of Singapore

On 22 January 2025, GHLIG Advisory Committee Member Professor Gian Luca Burci joined the National University of Singapore's Centre for International Law (CIL) for a full day conference in "International Law Year in Review: The United Nations at 80." Professor Burci spoke on the third panel of the day, addressing "International Law Responses to Planetary Threats," alongside his co-panellists: Mr. Lionel Yee, Deputy Attorney General, Attorney General's Office, Chambers, Singapore; and Dr. John Truby, Associate Research Professor in AI and Technology. Professor Burci's remarks offered an update on the ongoing pandemic treaty negotiations in the WHO's Intergovernmental Negotiating Body (INB).

The conference, titled "New Horizons of European, Global, and Comparative Health Law," was cohosted with the Max Planck Institute for Social Law and Social Policy, and the Max Planck Institute for Comparative Public Law and International Law.

Held at the Berlin-Brandenburgische Akademie der Wissenschaften, the workshop was followed by a public panel discussion at the same venue, featuring insights from Lawrence Gostin, Alicia Ely Yamin, Ilona Kickbusch and Gian Luca Burci, with a moderation by the Max Planck Institute's Alexandra Kemmerer. The workshop also featured significant announcements, including the launch

Towards Transformation in Global Health Law – Panel Discussion on 28 February 2025 Chaired by GHLIG's Advisory Committee Member, Professor Matiangai Sirleaf

On **28 February 2025**, the Maryland Journal of International Law will co-host a panel discussion with the Center for Global Engagement, at the University of Maryland, Baltimore, and the Law & Healthcare Program at the University of Maryland School of Law on the theme of "Towards Transformation in Global Health Law."

The event will feature a critical discussion on how ongoing reform efforts in global health can be structured to address health inequalities, including inequities in the medicines system worldwide. Panelists will consider topics such as the transformational potential of the Amendments to the International Health Regulations of 2005, efforts to draft an international treaty for pandemic preparedness, and beyond.

Chaired by the University of Maryland's Professor Matiangai Sirleaf, Nathan Patz Professor of Law, Francis King Carey School of Law and Professor, Department of Epidemiology and Public Health, School of Medicine, this conversation will serve as a catalyst for analyzing and reimagining the role of global health. Summer School in Global Health Law

Attention Master's students, Ph.D. candidates, as well as junior professionals with a legal background and interest in global health! The University of Geneva's Summer School in Global Health Law is returning this year, by popular demand!

This course will provide an advanced overview of global health law: the fundamental principles applicable, the actors involved, the legal norms already in place and their implementation, and the ongoing negotiations regarding new legal instruments. Special attention will be given to the WHO pandemic instrument that is currently being negotiated, as well as to the role played by global institutions that are particularly involved in the development and implementation of international norms. Students will learn through a combination of lectures, seminars, class discussions, practical exercises and field visits (including a visit to the World health Organization). The approach will be guided by the in-depth examination of specific global health challenges, and analyses provided by scholars as well as by practitioners involved in Geneva in the resolution of global health issues.
